# Subject: Implementation of Rooftop Solar Power Plants at all ESI Establishments under RESCO Mode by M/s REIL –reg.

#### **Reference:**

1. This office letter No. SE-IV/PS/Misc/2015-PMD/Solar dated 18.09.2024 and 03.04.2025.

# Sir/Madam,

Kind attention is invited towards above reference communication on the captioned subject. It is regretful to inform that even after repeated reminders only few field units have responded to the information/ATR sought by this office. Moreover, data submitted by the field units is not found in order leading to confusions and difficulties in taking further course of action.

As you may be aware that installation of solar PV rooftop on RESCO mode is a beneficial initiative, offering both economic and environmental advantages. The delay or failure in harnessing solar power would not only deprive ESIC of these benefits but also run counter to the broader national interest. The senior authorities have expressed disappointment due to delay in increasing coverage of solar generation capacity. It is also pertinent to inform that ministry is closely monitoring the progress on monthly basis.

In spite of fact that field units are better acquainted with site condition, supported by in-house engineering staff and Headquarters office has provided signed copy of MoU and Model PPA agreement, it is observed that some field units are forwarding unwarranted correspondence to Headquarters without any follow up action/ initiative to install roof top solar PV. REIL or their appointed developers are reporting non-cooperation by the field units. In view of above difficulties, competent authority has sought active participation of Regional Director with full responsibility for increasing coverage of solar generation capacity. In case site is not suitable for installation of solar PV rooftop plant same shall be informed with recorded reasons in remarks column to Headquarters office.

The Regional Director shall ensure installation of solar PV rooftop at all possible ESI sites under his jurisdiction state. Details of REIL contact person to be contacted is as under: -

In case data not submitted by the 10<sup>th</sup> day of month the Regional Director shall submit reasons for non-submission of data by 15<sup>th</sup> day of each month failing which the details of non-complaint regions shall be submitted to senior authorities for further action in the matter.
